

A Message from the Chairman of the Board



While Foundations often base their capacity to do good on their investment capital, in reality, their true capital are the individuals who are responsible for the governance, policy and operation. Such is the case with the Stackpole-Hall Foundation. Accordingly, 2019 was a year of unusual change in the human capital of the Foundation.

On December 31, 2018, yours truly retired as the Executive Director after 47 years of service. I was replaced by Mrs. Jennifer Dippold, who joined the Foundation on August 1, 2018. Jen brought a wealth of experience to the Foundation, having served in a leadership role for 22 years with Dickinson Center, a behavioral health organization that serves 8 counties in Northwestern Pennsylvania. Mrs. Dippold has served and continues to serve on several boards. The most active board would be the Women Who Care Advisory Board, a Board operating under the Elk County Community Foundation. This Board enables her to continue to support and advocate for local nonprofit organizations. Giving her wealth of knowledge regarding the needs and issues confronting the areas nonprofit organizations, she is well qualified to lead the Stackpole-Hall Foundation into the next decade.

Then, in April 2019, Mr. Denny Bonanno retired as the first Secretary Treasurer of the Foundation. Mr. Bonanno skillfully served for 22 years, directing the Foundation's financial operations and facilitating special projects such as the administration of the Summer Jobs Program and the publication of the Foundation's annual report. Mr. Bonanno was replaced by Mrs. Barbara Glatt. Mrs. Glatt came to the Foundation having managed the financial operations of the Elk County Community Foundation and The Community Foundation of the Northern Alleghenies.

Change did not end with staff transformation. Over the past dozen years, several trustees have retired after years of dedicated service. At the Foundation's annual meeting in November, the Permanent Trustees appointed three new Term Trustees effective January 1, 2020 - Frank Kaul, Rory Sheble-Hall, and Devon Turner.

After years of separation, Frank brings the historical reconnection of the Hall and Kaul families. Frank is the Great-great-grandson of Andrew Kaul; who, with J.K.P. Hall formed a logging, milling, railroad, mining, and banking partnership in the late 1800's.

Rory, served as the first Chairwoman of the Foundations Youth Advisory Board, the Great-granddaughter of Lyle G, Hall, founder of the foundation, granddaughter of Lyle Hall Jr. former Chair of the Foundation and daughter of Sandy Sheble-Hall long time Trustee of the Foundation.

Devon, an attorney in Charleston, SC, is the Granddaughter of Harrison C. Stackpole one of three of the founding donors of the Foundation, and daughter of Laurey Stackpole-Turner, a current member of the Board of Trustees.

And so, as a result of our new younger staff and board members, the foundation enters its eight decade of operation, well positioned to meet the challenges of the future.

A Message from the Executive Director

2019 had several notable moments, projects, changes, and events. In March, the Foundation welcomed Mrs. Barbara Glatt as our Finance Director. I am grateful that Barb accepted the position, knowing that the financial management of the Foundation is a key operational component. Barb is not only our Finance Director, but my sounding board, and the Board's Secretary and Treasurer. Quarterly, Barb helps me process grant proposals, so that I can provide quality information regarding these requests to the Board of Trustees.

Another notable moment, was our official farewell and retirement event for Dr. Conrad. Dr. Conrad officially retired December 2018, but did not go far, as he is the Board of Trustees Chair. In August, the Board of Trustees hosted a special retirement dinner for Dr. Conrad, his family, and the Trustees. We all had the opportunity to hear a tribute from Mr. Ray Beimel regarding Dr. Conrad's involvement in the community and his accomplishments. An accomplishment that I feel needs recognition would be the Dr. William C. Conrad Summer Jobs program. In 2019, the program celebrated 35 years. This was a vision of Dr. Conrad's and is now a staple program for the Foundation. Annually, the Trustees approve funding to support local nonprofits to employ Pennsylvania Higher Education Assistance Agency (PHEAA) eligible students for a 12-week period. Since inception, the Foundation has supported over 3,600 jobs and committed \$4.5 million in financial support.

2019 was an abundant year for the Foundation. We had the privilege to grant \$1.2 million back to Elk County organizations and other organizations near and dear to the Stackpole and Hall families. Our top three recipients include Penn Highlands Elk to support Pinecrest Manor's renovation project, WRC Senior Services renovation project, and Dickinson Center's new facility that will be constructed in St. Marys.

A final notable relates to the St. Marys Area United Way. In July, the Stackpole-Hall Foundation agreed to support the operations for the United Way. I will be the United Way Director and Barb Glatt will be the Finance Director. Stackpole-Hall is grateful for the opportunity to support the community and the philanthropy efforts of the St. Marys Area United Way.

Welcome Barbara E. Glatt




The Stackpole–Hall Foundation welcomed Mrs. Barbara Glatt to the Foundation as their new Finance Director in March 2019.

SUMMER JOBS PROGRAM - \$122,528

The Stackpole-Hall Foundation, in cooperation with the Pennsylvania Higher Education Assistance Agency (PHEAA), continued its successful Dr. William C. Conrad Summer Jobs program which began in 1985. This program allows college students from Elk County to gain work experience, ideally in their field of study, from non-profit agencies. In the joint effort, the Foundation provides funding for 40% of the wages earned, the Pennsylvania State Work Study program provides funding for 50%, and the employers are responsible for the remaining 10%.

This is an example of a passive treatment system. Western PA Conservancy use passive treatment systems to treat acid mine draining (AMD) discharges on properties. The primary pollutant in the AMD discharge to Cherry Run is aluminum, which is highly toxic to aquatic organisms. Aluminum can be easily removed from the water by letting it sit in contact with limestone, which raises the pH of the water, turning the dissolved aluminum into a solid that precipitates out of the water column.




RESTRICTED FUNDS - \$290,098

The Restricted Grants category resulted from funds designated by the bequests of Lyle G. Hall, Sr. and J. Hall Stackpole. The distribution, adjusted for the proportionate share of expenses and excise taxes, is paid annually to those organizations specified by Mr. Hall and Mr. Stackpole. The following is a listing of the earmarked recipients and the grant amounts.



Lyle G. Hall, Sr.

Lyle G. Hall, Sr. was born in St. Marys, PA, in 1886 but lived most of his life in Ridgway, PA. He attended Phillips Academy, Andover, Massachusetts, and graduated in 1910 from Yale University. Mr. Hall's community involvement was an abiding part of his personality. His dedication to the boy scout movement was probably one of his most fulfilling associations, in as much as he helped organize the Bucktail Council. Mr. Hall was known as a highly educated and refined gentleman with a great sense of humor. He enthusiastically supported every worth-while project or enterprise for the benefit of the people of Elk County. Mr. Hall passed away on April 28, 1958.

James Hall Stackpole was born in Ridgway, Pennsylvania, but lived most of his life in St. Marys. He graduated from Hotchkiss Preparatory School in 1920 and graduated from Yale University in 1924. After completing his formal education, he returned to Elk County taking permanent employment at the Stackpole Carbon Company and elected Chairman of the Board, a position he held until he passed away on August 21, 1964. When he passed, the local newspaper described him as one noted for his willingness to extend a helping hand and financial assistance to an untold number of people who appealed to him, and that his life was filled with acts of kindness that have endeared him to the hearts of many.

Independent Auditor's Report

Board of Trustees The Stackpole-Hall Foundation

We have audited the accompanying financial statements of The Stackpole-Hall Foundation (Foundation), which comprise the statements of financial position as of December 31, 2019 and 2018, and the related statements of activities and cash flows for the years then ended, and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.


